BOOKING INFORMATION / RENTAL TERMS 2025

PAYMENT

10 days after booking, the registration fee of 20% (minimum 200 SEK) must be paid. If the registration fee is not paid, the spot may be considered cancelled. The remaining fee must be received by us no later than 50 days before arrival. The date is stated on your invoice. When paying, please state the invoice number and the name of the person who booked. For short periods between booking and arrival, a separate agreement with the booking staff applies.

CANCELLATION WITHOUT CANCELLATION PROTECTION

Applies only to camping plot/cabin: For cancellations earlier than 20 days before arrival, you will pay an administration fee of 500 SEK. The registration and booking fees are non-refundable. For cancellations later than 20 days before arrival, you must pay the full rent.

CHANGE OF BOOKING - applies to all bookings

A change involving a different arrival day, departure day or other accommodation is considered a cancellation and a new booking. We then charge a booking fee of SEK 135 which is added to the new invoice.

CANCELLATION WITH CANCELLATION PROTECTION

Applies only to camping plot/cabin: Cancellation protection costs 250 SEK per camping plot/cabin and means that in the following cases, which were not known at the time of booking, you can cancel up to the day before arrival: Death, illness, or serious accident affecting yourself, spouse, partner, family, or fellow traveller. The occurrence of another serious event beyond your control that makes it unreasonable to expect you to adhere to your booking. You must be able to substantiate your impediment with a certificate from, for example, a doctor, authority, or insurance company. The certificate must be received by us as soon as possible. The fee for cancellation protection, as well as the registration fee, is non-refundable in case of cancellation. Up to 20 days before arrival, you can cancel without needing a certificate.

CANCELLATION

Applies only to rooms: For cancellations earlier than 7 days before arrival, you will pay an administration fee of 200 SEK. For cancellations later than 7 days before arrival, you must pay the full rent.

ON ARRIVAL CAMPING – CHECK-IN from 14:00

When checking in at the campsite reception, a valid camping card or camping ID must be presented. If you do not have a camping card or camping ID, we can help you with this at the reception.

ON ARRIVAL CABIN, ROOM, OR GLAMPING TENT - CHECK-IN from 15:00

At the reception, a valid camping card or camping ID must be presented. If you do not have a camping card or camping ID, we can help you with this at the reception. You can scan this QR code to get it. It's completely free of charge and no following marketing,



CAMPING KEY

Information on how we handle your personal data can be found below under GDPR. If you wish to book cabin cleaning, this can be done no later than upon your arrival for 1050 SEK.

ON DEPARTURE

Rooms & cabins must be vacated by 11:00 on the day of departure. Camping plots must be vacated by 12:00 on the day of departure.

If the guest chooses to check out earlier than the agreed-upon day, we reserve the right to rent the space to another guest.

Rooms: The guest is responsible for dusting, vacuuming the room, and airing out the bed linens before departure. Make sure to empty the refrigerator and wipe it down after use. **Cabins:** The guest is responsible for cleaning the cabin before departure. Follow the cleaning checklist you received at check-in. The checklist must be signed and returned to the reception at check-out. After check-out, the cabin will be inspected. If cleaning is not satisfactory, you will be charged a fee of 1500 SEK. An invoice will be sent to the address provided at booking. **Camping plots:** Checking out after 12:00 incurs a new daily fee.

INVENTORY

Rooms: Each room has blankets and pillows. Sleeping bags are NOT allowed. You must bring your own bed linen and towels. A TV is available in the common area. There is a shared kitchen with complete equipment for self-catering. Shared shower and toilet facilities. Any damage to the inventory will be compensated by the tenant. Please let us know if anything is broken so we can replace it.

CABINS

Each cabin has complete equipment for self-catering. This includes blankets, pillows, crockery, and kitchen utensils, as well as cleaning equipment including a vacuum cleaner. TVs are available in all cabins except Klubbhuset and Lillstugan. Freezers and ovens are only available in Graniten, Storstugan, and the mobile homes. You must bring your own bed linen, towels, consumables such as household/toilet paper, dishwashing liquid, etc. Any damage to the inventory will be compensated by the tenant. Please inform the reception if something is broken so we can help you replace it.

For a fee of 200 SEK each, sets of bed linen and towels are available for rent at the reception.

VEHICLES – you will receive a parking permit at check-in, please return at departure.

Rooms: Only one vehicle per rented room may be brought into the area and parked next to Villa Harmoni.

Cabins: Only one vehicle per rented cabin may be brought into the area and parked next to the cabin. Exceptions for 6-bed cabins where two cars may be brought into the area.

Camping plots: Only one vehicle per rented camping plot may be brought into the area and parked next to the caravan/tent.

Note! Other vehicles can, subject to availability, rent parking at Johannesvik's entrance or SMS parking outside the area. For long-term parking, we refer to the municipality's parking lots.

SMOKING/VAPING

At Johannesvik, smoking/vaping is prohibited in all rooms, cabins, and common areas. If smoking/vaping is detected, a cleaning fee of 1500 SEK may be charged.

PETS

Bringing pets is prohibited in all cabins as well as the rooms in Villa Harmoni. Exceptions in the following cabins for a fee of 250 SEK:

Askbacken: 30 – 32, 42 – 43 & 60. Lökåsen: 2 – 6. Golfbyn: 73 – 75. Graniten: 24. Klubbhuset

TENANT'S RESPONSIBILITY

The tenant is obliged to follow the rules and instructions that apply to the camping area. Anyone who does not follow this can be evicted from the area with immediate effect. The tenant is obliged to financially compensate for damage or theft caused by you or your guests.

GDPR

Johannesvik Camping is responsible for the processing of the personal data you register. Your data will NOT be sold. The data will only be used by Johannesvik Camping. Johannesvik Camping will process your personal data to administer your booking and payment of your camping site, to send information regarding offers, news to you as a guest, and information you have requested. Anyone who has booked a stay has the right to once a year, free of charge, request in writing to see what data has been registered and where the data has been obtained from. You have the right to request correction of any changed or incorrect data at any time. Johannesvik Camping will store your data until the end of the year, provided you have not made a booking for the coming year. If you do not wish to have your data stored with us, this must be notified to Johannesvik Camping. The data will then be deleted after your stay. When you make your booking, you agree that Johannesvik Camping may save your personal data.
